HOLD HARMLESS

WHEREAS, the undersigned acknowledges the inherent risks involved in riding and working with and being around horses, which include bodily injury from caring for, using, riding, or being in close proximity to horses, among other risks, and further, that both horse and rider can be injured in normal use or in schooling and competition and in exhibition.

IN CONSIDERATION, therefore, for the privilege of attending clinics, seminars, exhibitions, taking riding lessons or schooling and riding horses at any event presented by The Lightness Foundation LLC, Manuel Trigo, Angela and Philip Garvin, the Undersigned, and any agent, employee, volunteer or associate connected with Undersigned, do hereby agree to hold harmless and indemnify and further release The Lightness Foundation LLC, Manuel Trigo, Angela and Philip Garvin from any liability or responsibility for accident, damage, injury, or illness to the Undersigned or any horse owned by the Undersigned or to any Family member, associate or spectator accompanying the Undersigned while on the premises during a equestrian event held on March 3rd 2017 through March 5th 2017 at White Stallion Creek Ranch, 5723 E Yucca Road, Cave Creek, AZ 85331: I, the Undersigned, shall bring no claims, demands, actions and causes of actions and or litigation, against this facility and or property for any economic and non-economic losses due to bodily injury, death and or property damage sustained by me or my Family, or workers, in relation to the premises and operation of The Lightness Foundation LLC, including employees and volunteers, Manuel Trigo and Angela and Philip Garvin, including while riding, handling, being a spectator or being near horses owned by or in the care, custody and control of this facility.

For Riders: I, the Undersigned, further assure The Lightness Foundation LLC, Manuel Trigo, Angela and Philip Garvin and all agents, that I am an experienced rider of horses and will not engage in activities that are beyond my abilities to complete. I, the Undersigned, commit to informing the organizers of this tournament if I cannot safely and comfortably complete the suggested task, movement or handling of my horse as needed. All riders, whenever mounted, should be wearing a riding helmet which meets or exceeds ASTM/SEI standards for equestrian use and carries the SEI tag. The headgear and harness must be secured and properly fitted. This applies to warm-up, competition, and non-compete horses. If I, the Undersigned, choose to NOT wear a helmet, you are doing so at your own risk and assume all responsibility for your actions.
